

TERMS and CONDITIONS of Sales

1. All sales are final and must be paid by:
 - A. Irrevocable Letter of Credit at sight, ex-works factory S. Martino della Battaglia – Brescia - Italy
2. All bank charges, freight, insurance, cartage, bank commissions are to be to the account of issuer
 - A. Telegraphic transfer to our bank
 - B. Credit card sales is available and must be quoted separately upon request
 - C. All special orders (custom compressors) will require 50% deposit with order, with 50% balance due prior to shipping
 - D. All payments must be in Euro
 - E. No C.O.D. shipments accepted
3. Prices are subject to change without notice. Orders are accepted subject to prices prevailing at time of shipment, including back orders. A service charge of €25.00 added to orders less than €100.00, including part orders.
4. Possession of a Aerotecnica Coltri Srl catalogue or price list does not constitute an offer to sell.
5. Aerotecnica Coltri Srl reserves the right to reject any and all orders.
6. All back orders under €100.00 will be cancelled
7. Transshipments are not allowed without written authorization from Aerotecnica Coltri Srl.
8. All sales are ex work factory S. Martino della Battaglia – Brescia - Italy (if you wish prepaid & add you are also responsible for claims)
9. **DELIVERY TO CARRIER CONSTITUTES DELIVERY TO CUSTOMER.**
10. **ALL CLAIMS FOR DAMAGES DURING SHIPPING IS THE CUSTOMER'S RESPONSIBILITY AND MUST COMPLY WITH THE FREIGHT COMPANY, UPS, RPS, TRUCK, ETC POLICY. IN MOST CASES THIS CLAIM MUST BE DECLARED IN WRITING WITHIN 5 DAYS OF RECEIPT OF GOODS. VISUALLY DAMAGED CARTONS MUST BE DECLARED AND SIGNED BY DRIVER AT TIME OF DELIVERY.**

RETURN and REPLACEMENT

1. All returns must be authorized and shipped prepaid. NO C.O.D. shipments will be accepted.
2. All shipments must be clearly labeled with the Return Goods Authorization number. Any shipment received without this number will be refused.
3. Authorized returns of sellable merchandise, other than shipments made in error, are subject to a 25% restocking charge.
4. Claims for shortage, miss-shipments or incorrect pricing must be made to Aerotecnica Coltri Srl within 15 days from invoice date.
5. Returned merchandise will be repaired or replaced at Aerotecnica Coltri Srl discretion. Out of warranty merchandise is subject to incurred labor, parts and return shipping charges.
6. When returning any items specifically for credit, give the appropriate invoice number, date and reason for return.

FOREIGN Customers TERMS and CONDITIONS

1. Minimum foreign order will be €10,000.00 (NO C.O.D.) shipments to foreign countries. Orders under the minimum are subject to a €50.00 handling charge. All quoted prices are in U.S. dollars.
2. All orders are to be paid by Irrevocable Letter of Credit at sight (min. order €10,000.00). Orders under €10,000.00 are cash in advance by wire transfer.
3. Proforma invoice prices and delivery are good for 30 days from date of the Proforma Invoice.
4. Shipping, insurance, documentation and crating charges will be added to invoice amount (at cost).
5. Order shipped cheapest way, unless otherwise specified by customer.
6. All orders shipped EX-WORKS FACTORY S. Martino della Battaglia – Brescia - Italy.
